2	<p>Matters Arising:</p> <ul style="list-style-type: none"> • Previous minutes were approved and signed. • Malcolm updated us on the letter to be sent by the Kingston Society and supported by NKF regarding the Market House. We have interest in the possibility of this becoming an Urban Room. David asked if there was a Charter covering the Market Square and Market House, and it would be good to view when available. 		
3	<p>Update on the draft NPlan: We have just received the draft HRA Screening Opinion from RBK. Di went on to say the council has issued a positive draft saying they are now required, as per the regulations, to share the plan with Natural England for their comments. The council's Screening Opinion is very positive about the Plan. The AECOM Sustainability Appraisal and our Basic Conditions Statement have been uploaded to the server. Di is working on the Consultation Statement and finishing the maps.</p>

5	<p>Meetings over the summer months: - we agreed that we should not have a scheduled meeting until September unless issues warranting a meeting occur.</p>		
6	<p>Police Panel meeting on Domestic Violence: Jonathan raised the issue of the next Police Panel meeting on 29 May at 7.00 pm in the Pavilion in Canbury Gardens and asked for members to pass on the information.</p>		
7	<p>AOB: Farshid said Kingston Hospital was merging with Hounslow and Richmond Community Healthcare later this year and promised to keep us updated.</p> <p>He then asked David if he participated in the home charging scheme and asked for more details.</p> <p>David asked if there were any outstanding invoices. Di shared her screen and there are invoices totalling £522 waiting payment. This is to cover the AGM Agenda pack and NKNPlan Policy Summary Statement leaflet which can be deposited at the local library and central library in the Town Centre. The payment to Di was approved. The invoices are attached to these minutes.</p> <p>James said the position of Canbury car park is still under discussion. The TFL transport position is still being updated.</p> <p>No application has been submitted for the Bingo Hall as yet, but we are aware that an independent Design Review has been carried out.</p> <p>David asked if were expecting any more invoices; none planned.</p>		

	<p>David asked if the Cromwell Road building was in our area. This proposed redevelopment is just outside our boundary area.</p> <p>The Barnfield building has a new tenant and there will be minimal structural work required. In consequence the stables will be protected.</p> <p>The new proposed Town Centre Leisure Centre design has been completed and has all the amenities on a much smaller footprint. Consultation will start shortly.</p> <p>James asked if the NKF would like a stall in Canbury Gardens dragon boat racing on 21st July.</p> <p>Canbury Secrets has been sold and now has new owners.</p> <p>Malcolm raised the issue of the Keep and the planning application and expressed concerns about the proposal.</p>

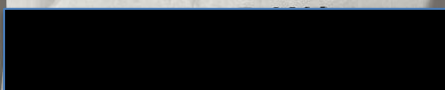
